Strategic Environmental Assessment (SEA) Screening Opinion

Wadhurst Neighbourhood Plan and Wadhurst Design Code (Pre-Regulation 14)

October 2022

Prepared by Wealden District Council

1. Introduction

- 1.1 This screening report is designed to determine whether the draft Wadhurst Neighbourhood Development Plan (NDP), including the Wadhurst Design Code, require a Strategic Environmental Assessment (SEA) in accordance with the European Directive 2001/42/EC ("The SEA Directive")1 and associated Environmental Assessment of Plans and Programmes Regulations 2004 (The "SEA Regulations")2.
- 1.2 A neighbourhood plan may require a Strategic Environmental Assessment (SEA) to comply with the SEA Directive where it is likely to have significant environmental effects. It is the Council's responsibility to determine whether the plan is likely to have significant environmental effects taking account of the criteria set out in Schedule 1 of the Environmental Assessment of Plans and Programmes Regulations 2004, and in consultation with the Environmental Agency, Historic England and Natural England.
- 1.3 In order to decide whether a proposed neighbourhood plan is likely to have significant effects on the environment it is 'screened' at an early stage once the plan remit and objectives have been formulated. This report assesses the draft of the Wadhurst Neighbourhood Plan dated 15 August 2022 and the Wadhurst Design Code dated March 2022 (Pre Regulation 14 stage).
- 1.4 If, after the screening assessment and consultation with the statutory bodies, the responsible authority determines that the neighbourhood plan is likely to have significant environmental effects, then a full Environmental Assessment will be required. Conversely, if it is determined through screening and consultation with the statutory bodies that the neighbourhood plan is unlikely to have significant environmental effects, then the neighbourhood planning group need not concern itself with subsequent stages of the SEA process.
- 1.5 The Council advises neighbourhood plan groups to undertake a Sustainability Appraisal to assess the impact of the Neighbourhood Plan against social, environmental and economic factors. This is good practice and can provide evidence for how the neighbourhood plan meets the requirement to promote sustainable development.

2. Overview of the Wadhurst Neighbourhood Plan and Wadhurst Parish

- 2.1 The Wadhurst NDP has previously been out to Regulation 14 consultation. However, the neighbourhood plan changed substantially between the Regulation 14 and Regulation 15 Stages, including the addition of new policies and a new Design Code. On this basis and on the advice of Wealden District Council, Wadhurst will undertake a Regulation 14 consultation on their revised neighbourhood plan to provide an opportunity for the community to have their say on the revised neighbourhood plan as well as the Design Code that will accompany the neighbourhood plan. Prior to a second Regulation 14 consultation it is necessary to re-screen the Neighbourhood Plan and also screen the Design Code given its policy connection in that there are a number of policy hooks in the NDP which require compliance with the design guide. In addition, since the Design Code will apply to heritage assets, such as Conservation Areas, in principle it is capable of requiring an SEA.
- 2.2 The plan covers Wadhurst Parish, which is located wholly within the High Weald Area of Outstanding Natural Beauty. The parish contains large areas of Ancient Woodland and Bewl Water Reservoir, which is identified as a Local Wildlife Site and Biodiversity Opportunity Area (BOA). There are a number of other Local Wildlife Sites within the parish including Butchers Wood, Colesgrove Wood Complex and Snape House Meadow. The western most part of the parish falls within the Medway, Ouse, Rother Watershed BOA and part of the southern parish boundary is within the Rother, Brede and Tillingham Woods BOA.
- 2.3 There are no Special Areas of Conservation, Special Protection Areas, Ramsar sites, Sites of Scientific Interest, National Nature Reserve or Local Nature Reserve designations within the neighbourhood area. However, Eridge Park Site of Special Scientific Interest abuts the neighbourhood area boundary to the west of the parish.
- 2.4 In terms of Heritage Assets, in Wadhurst Parish there are two Conservation Areas (Wadhurst Conservation Area and Pell Green and Cousley Wood Conservation Area), a Grade II Registered Park and Garden at Wadhurst Castle and over 150 Listed Buildings. There is also a Scheduled Monument, Riverhall Blast Furnace, on the border with Frant Parish, and a number of Archaeological Notification Areas within the parish.
- 2.5 The Plan sets out a vision, objectives and policies covering a plan period to 2036. The Plan does not allocate sites for development. The Plan sets out a vision statement:

Wadhurst Parish will continue to be a collection of friendly and vibrant distinct communities. The Parish will retain and support its rural 'village feel', historic character and heritage. Justifiable, sensitive and sustainable development will be supported, whilst robustly protecting the High Weald Area of Outstanding Natural Beauty. The Parish economy and its popular High Street will be revitalised by improvements to the roads, traffic control, parking and active support of businesses. Sustainable ways of improving travel and leisure activities and facilities, which promote wellbeing, will be sought wherever possible.

2.6 The plan's objectives are:

- Objective 1 Character, Heritage and Design: To provide sympathetically
 designed high quality housing for parishioners that meets local housing needs
 while enhancing the distinctive natural and built character of the Parish
 through justified, sensitive, sustainable development and healthy
 placemaking. Recognising and protecting the individual and distinctive
 settlements that comprise the Parish.
- Objective 2 Getting Around: To address local transport issues, including traffic and parking issues and promoting sustainable transport options by improving connectivity to facilities within and beyond the Parish by integrating and, where possible, extending the existing network of footpaths and bridleways.
- Objective 3 Local Economy: To support and extend business, employment and associated training opportunities – including provision of infrastructure required – to grow the local economy, and to support the development of the Parish as a sustainable and environmentally friendly destination for those visiting the High Weald.
- Objective 4 Environment: To enhance and maintain the rural character and landscape features of the Parish, that led to the area's designation as the High Weald Area of Outstanding Natural Beauty. This includes promoting opportunities for supporting and improving biodiversity, safeguarding valued green spaces and access to these, and protecting key viewpoints afforded by the Parish's ridgeline location.
- Objective 5- Community Wellbeing and Leisure: To retain and, where possible, expand the range of facilities and amenities available for local residents.

3. **SEA Screening Assessment**




Figure 1: Application of the SEA Directive to plans and programmes

3.1 The screening assessment for the SEA is undertaken in two parts and will firstly assess whether the Wadhurst NDP and Design Code require an SEA as per the detailed guidance contained within 'A Practical Guide to the Strategic Environmental Assessment Directive' that is shown in Figure 1 that follows below³. The second element of the assessment will consider whether the Wadhurst NDP and Design Code are likely, in their current form, to have a significant effect on the environment, using the criteria drawn from Schedule 1 of the SEA Regulations. Figure 1 below is a guide as to how the criteria for the application of the Directive should be assessed.

3.2 The process in figure 1 has been undertaken in terms of the Wadhurst NDP and the findings can be viewed in Table 1. This establishes whether this NDP would require an SEA. The questions in table 1 are drawn from the diagram above which sets out how the SEA Directive should be applied.

4. **SEA Screening Conclusion**

- 4.1 As a result of the assessment at Section 3, it is considered by Wealden District Council that an SEA will not be required for the Wadhurst Neighbourhood Plan (including the Wadhurst Design Code).
- 4.2 This report was sent to the three statutory bodies for comment (Historic England, Environment Agency and Natural England). Each body agreed with the Council's conclusion that the Wadhurst NDP is not likely to have a significant effect on the environment and an SEA is therefore not required. The consultee's responses are provided at Appendix 1.
- 4.3 This screening opinion is considered to be a 'snapshot in time' and if the scope and/or policies contained within the Wadhurst NDP should change, then a new screening process will need to be undertaken to determine whether an SEA would be required at that time.

Wadhurst Neighbourhood Plan – Review SEA & HRA Screening

Thank you for your consultation on the above dated and received by Natural England on 09 September 2022.

Natural England is a non-departmental public body. Our statutory purpose is to ensure that the natural environment is conserved, enhanced, and managed for the benefit of present and future generations, thereby contributing to sustainable development.

Screening Request: Strategic Environmental Assessment

It is our advice, on the basis of the material supplied with the consultation, that, in so far as our strategic environmental interests (including but not limited to statutory designated sites, landscapes and protected species, geology and soils) are concerned, that there are unlikely to be significant environmental effects from the proposed plan.

Neighbourhood Plan

Guidance on the assessment of Neighbourhood Plans, in light of the Environmental Assessment of Plans and Programmes Regulations 2004 (as amended), is contained within the <u>National Planning Practice Guidance</u>. The guidance highlights three triggers that may require the production of an SEA, for instance where:

- a neighbourhood plan allocates sites for development
- the neighbourhood area contains sensitive natural or heritage assets that may be affected by the proposals in the plan
- the neighbourhood plan may have significant environmental effects that have not already been considered and dealt with through a sustainability appraisal of the Local Plan.

We have checked our records and based on the information provided, we can confirm that in our view the proposals contained within the plan will not have significant effects on sensitive sites that Natural England has a statutory duty to protect.

We are not aware of <u>significant</u> populations of protected species which are likely to be affected by the policies / proposals within the plan. It remains the case, however, that the responsible authority should provide information supporting this screening decision, sufficient to assess whether protected species are likely to be affected.

Notwithstanding this advice, Natural England does not routinely maintain locally specific data on all potential environmental assets. As a result the responsible authority should raise environmental issues that we have not identified on local or national biodiversity action plan species and/or habitats, local wildlife sites or local landscape character, with its own ecological and/or landscape advisers, local record centre, recording society or wildlife body on the local landscape and biodiversity receptors that may be affected by this plan, before determining whether an SA/SEA is necessary.

Please note that Natural England reserves the right to provide further comments on the environmental assessment of the plan beyond this SEA/SA screening stage, should the responsible authority seek our views on the scoping or environmental report stages. This includes any third party appeal against any screening decision you may make.

Habitats Regulations Assessment (HRA) Screening

Natural England agrees with the report's conclusions that the Wadhurst Neighbourhood Plan would not be likely to result in a significant effect on any European Site, either alone or in combination and therefore no further assessment work would be required.

The supporting information supplied with the consultation indicates that within the plan area there is a range of designated historic environment assets. There is also likely to be other features of local historic, architectural or archaeological value, and consideration should also be given to the wider historic landscape.

However as with our previous comment (02/07/2021) the plan is unlikely to have significant environmental effects within our areas of interest and, as such Historic England concurs with the Council's view that a Strategic Environmental Assessment will be not be required.

Historic England strongly advises that the conservation and archaeological staff of the relevant local authorities are closely involved throughout the preparation of the plan and its assessment. They are best placed to advise on; local historic environment issues and priorities, including access to data held in the Historic Environment Record (HER), how the allocation, policy or proposal can be tailored to minimise potential adverse impacts on the historic environment; the nature and design of any required mitigation measures; and opportunities for securing wider benefits for the future conservation and management of heritage assets.

We should like to stress that this opinion is based on the information provided by you with your correspondence below. To avoid any doubt, this does not reflect our obligation to provide further advice on later stages of the SEA process and, potentially, object to specific proposals which may subsequently arise (either as a result of this consultation or in later versions of the plan/guidance) where we

consider that, despite the SEA, these would have an adverse effect upon the environment.
